

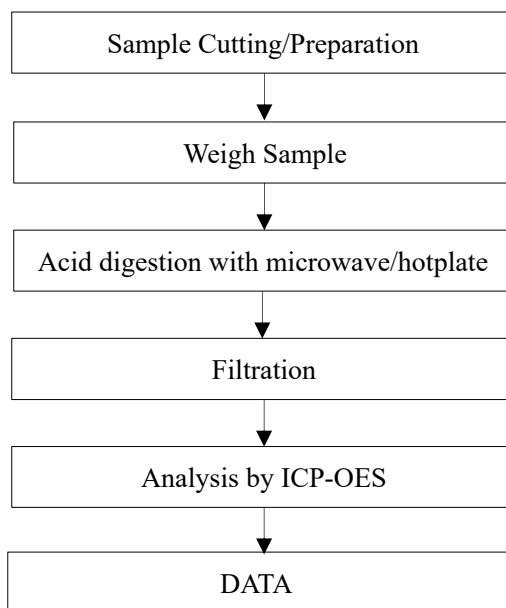

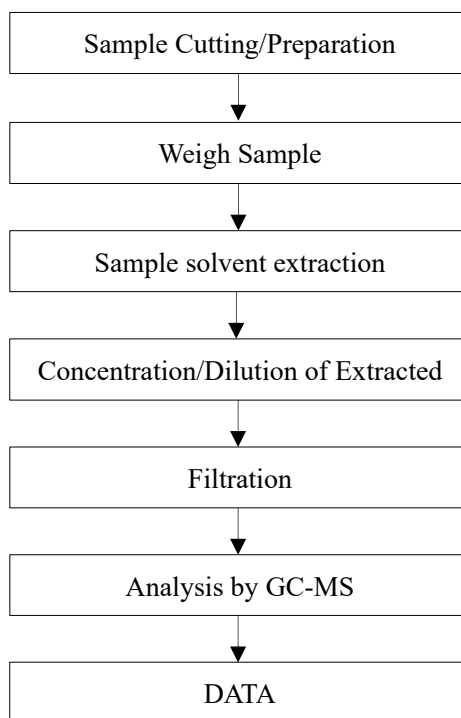

### Test Flow Chart of Phthalates



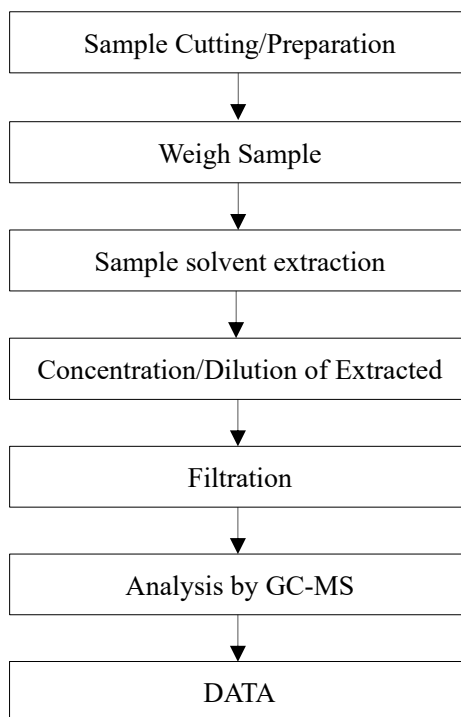

### Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)



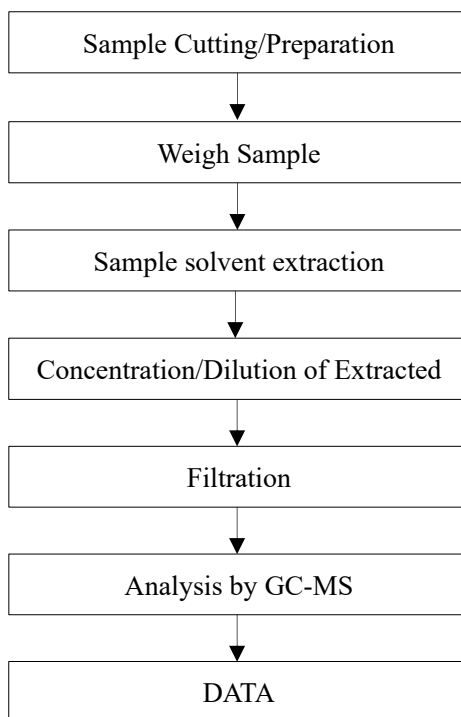

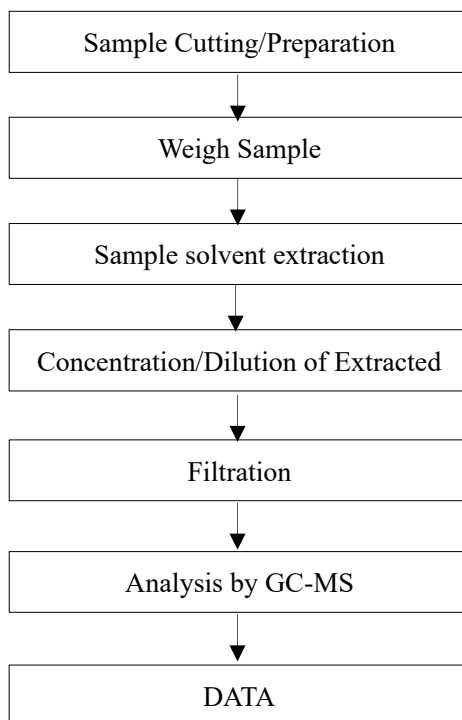
