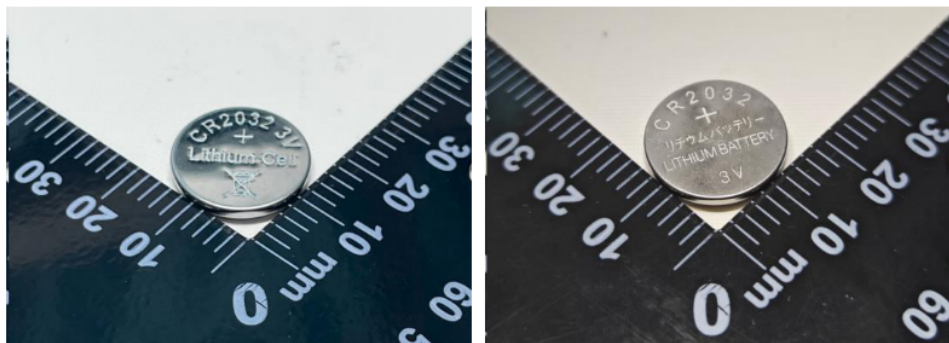

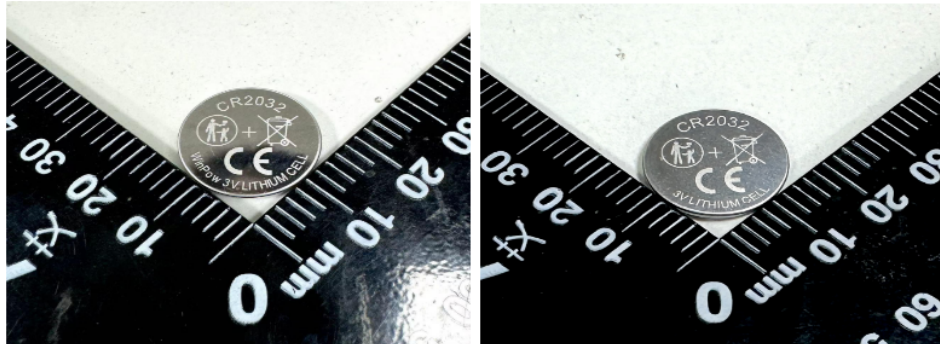
Cell/电芯 (CR2032 3V 210mAh)
