

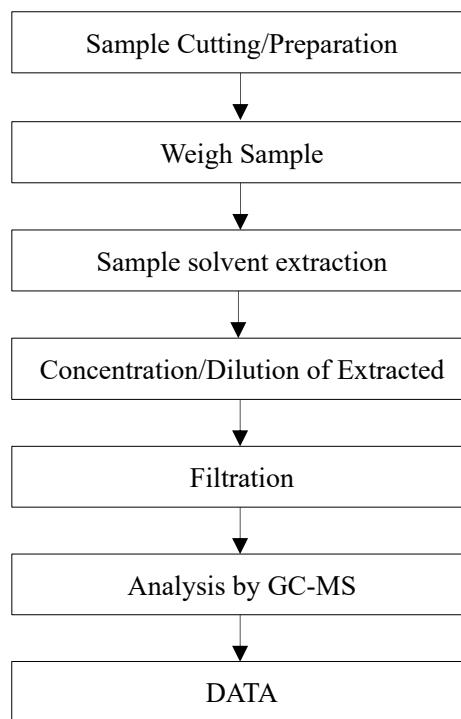
**Test Flow Chart of Heavy Metal Content**


**Test Flow Chart of Phthalates**
