





# **Test Flow Chart of Heavy Metal Content**



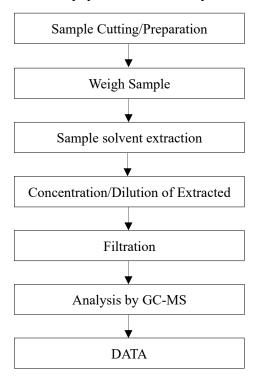
#### **Test Flow Chart of Phthalates**








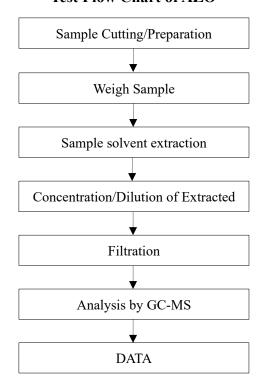
# Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)









#### **Test Flow Chart of AZO**








# **Test Flow Chart of Monoaromatic Hydrocarbons**
