In order to quantify the mass loss, the following procedure is provided:

Mass loss (%) = $(M_1 - M_2)/M_1 \times 100$

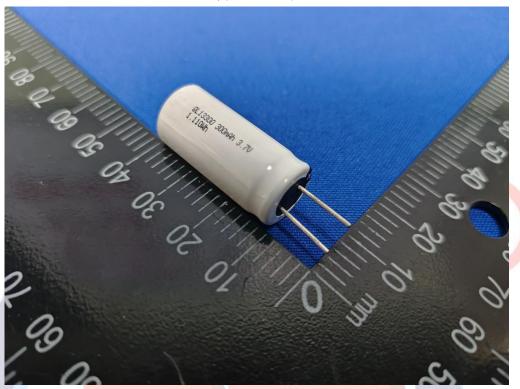

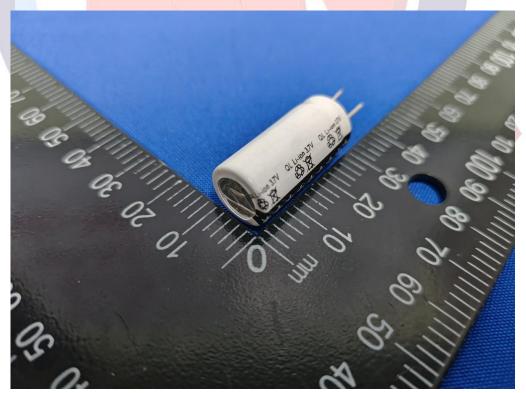
