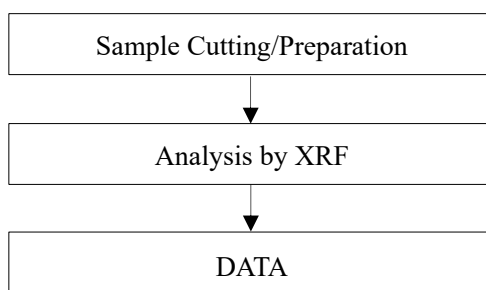

**Test Flow Chart of XRF**


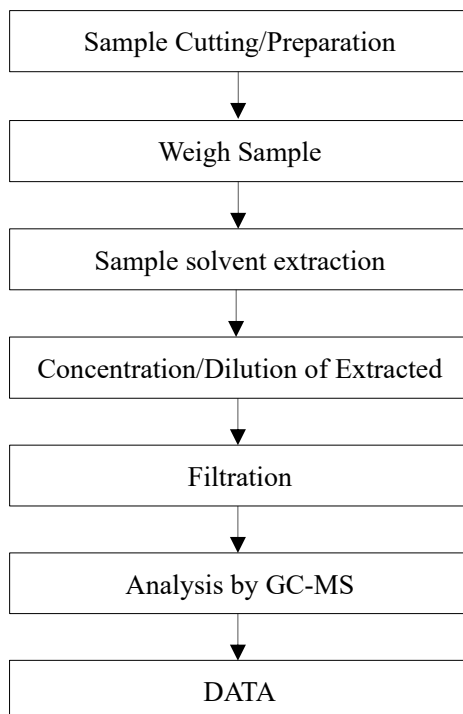

### Test Flow Chart of Phthalates

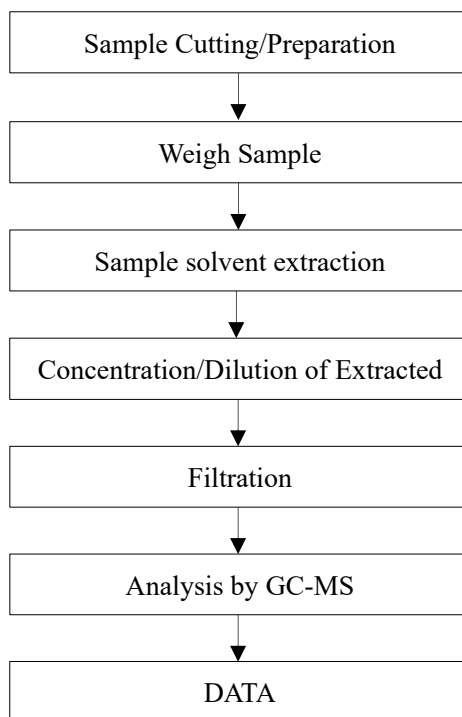

**Test Flow Chart of PBBs and PBDEs**

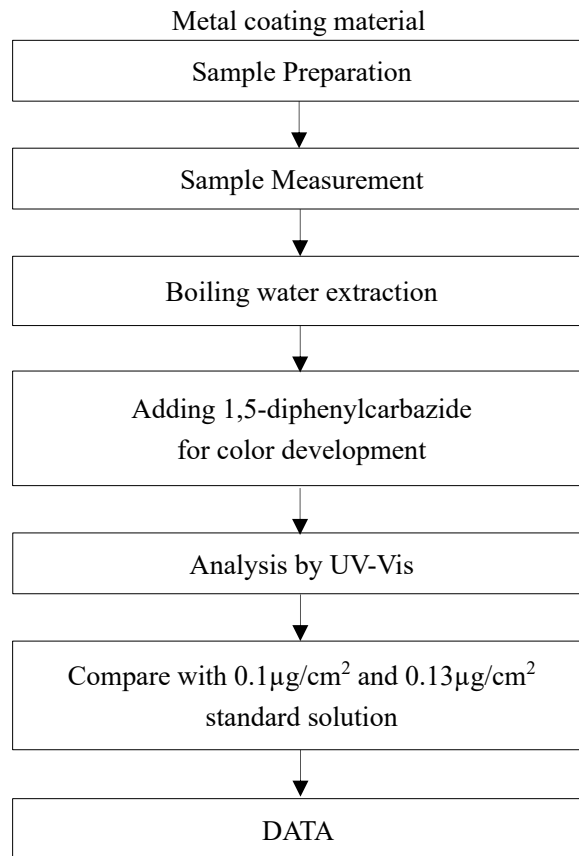

### Test Flow Chart of Hexavalent Chromium (Cr<sup>6+</sup>)



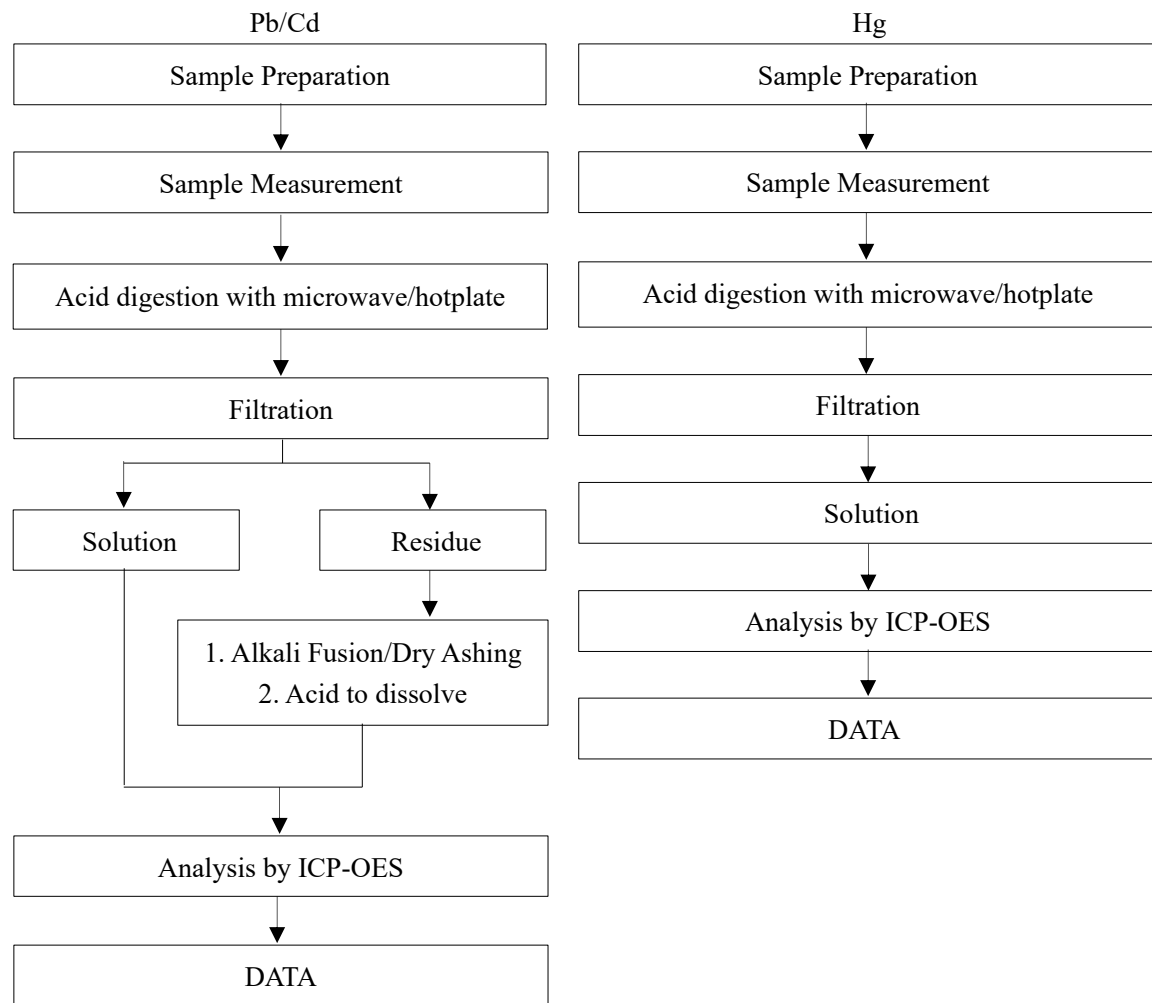
