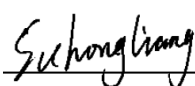

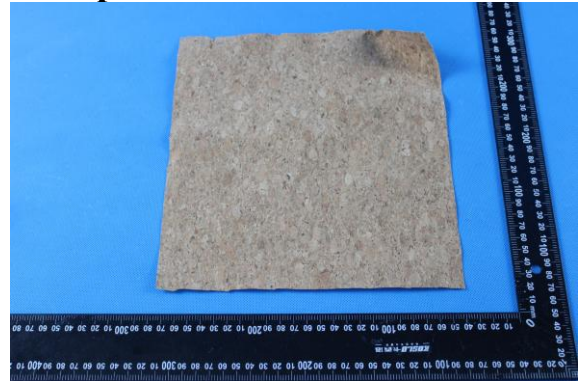

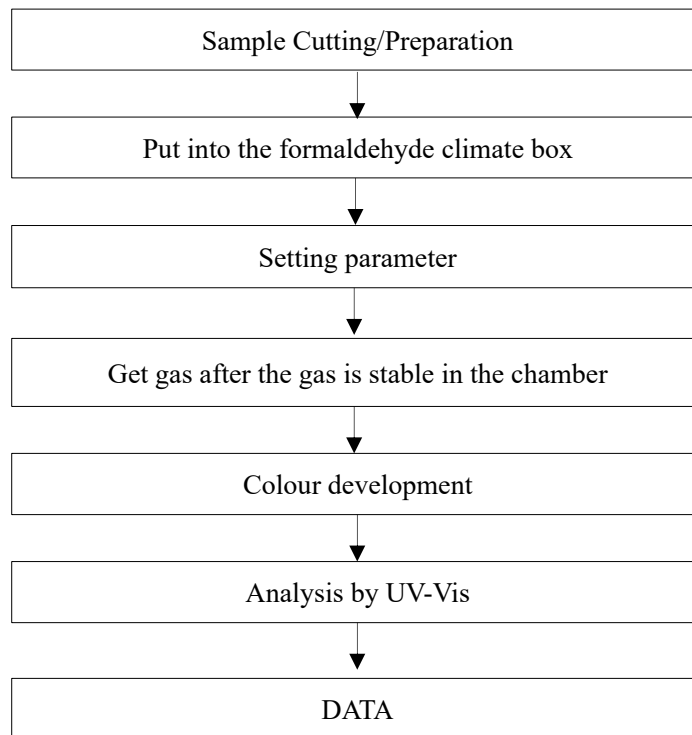

Test Flow Chart of Formaldehyde Release



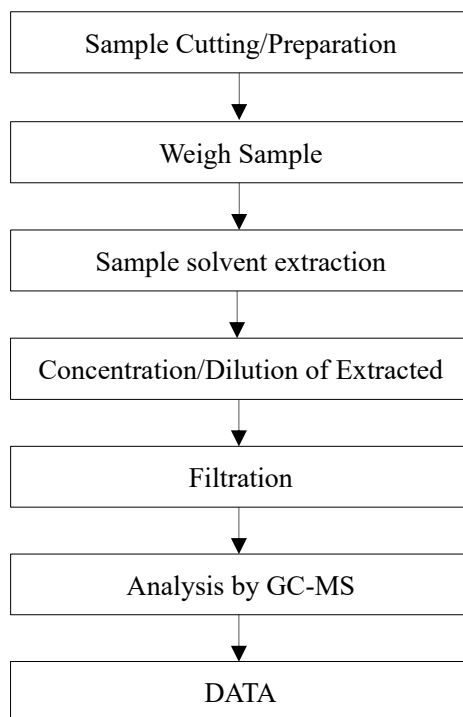

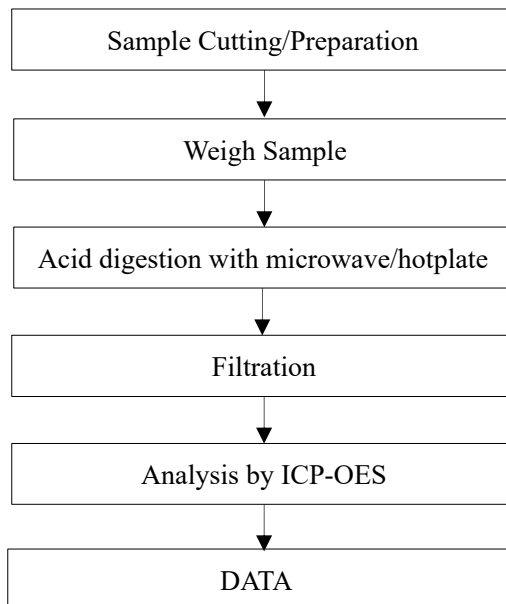
