






Test Flow Chart of XRF



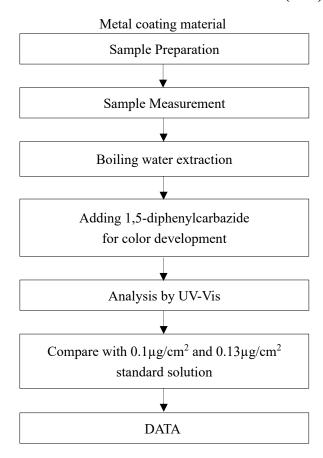
Test Flow Chart of Phthalates
