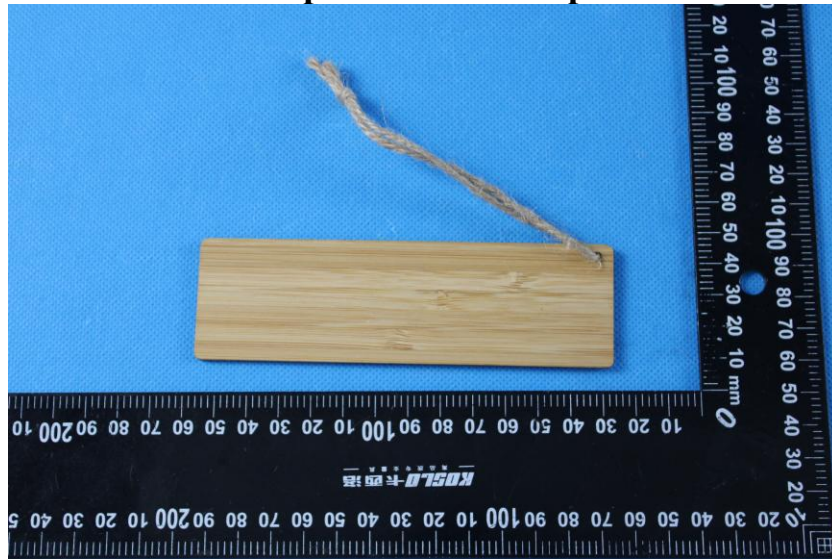

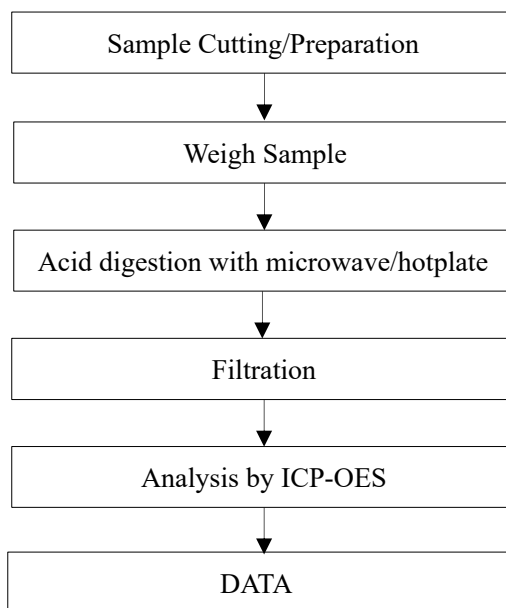

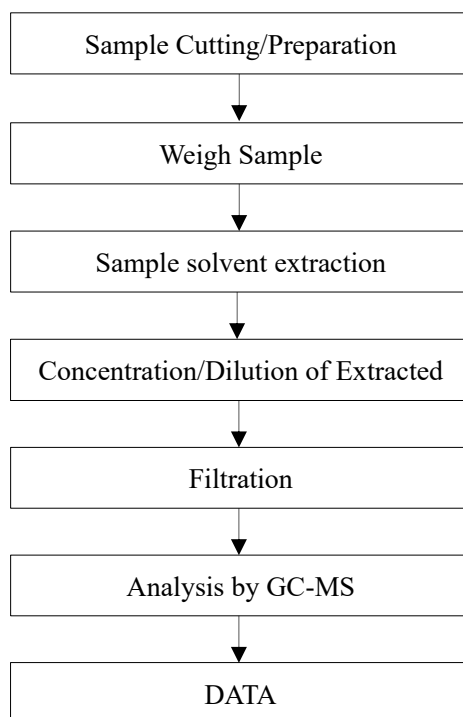

Test Flow Chart of Pentachlorophenol (PCP)



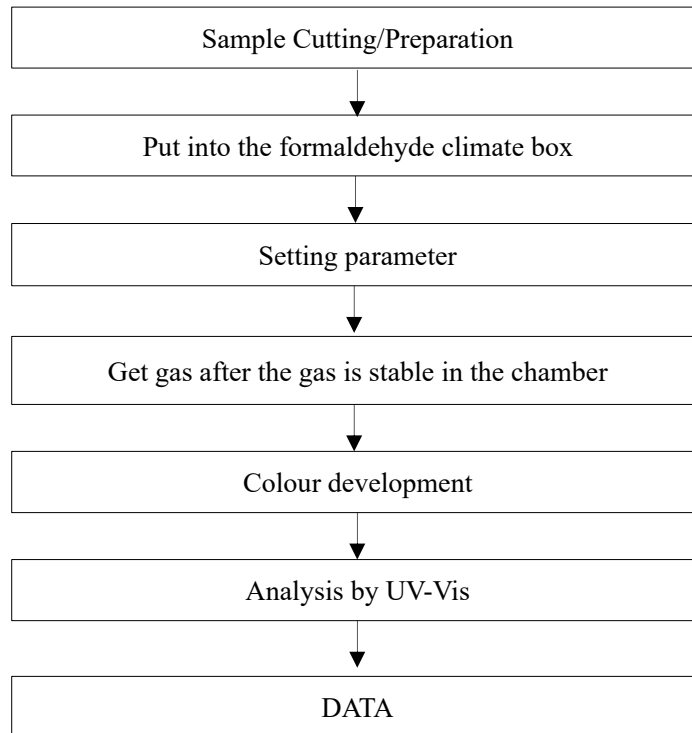
