



Test Flow Chart of Heavy Metal Content**Test Flow Chart of Phthalates**


Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)


Test Flow Chart of AZO


Test Flow Chart of Pentachlorophenol (PCP)
