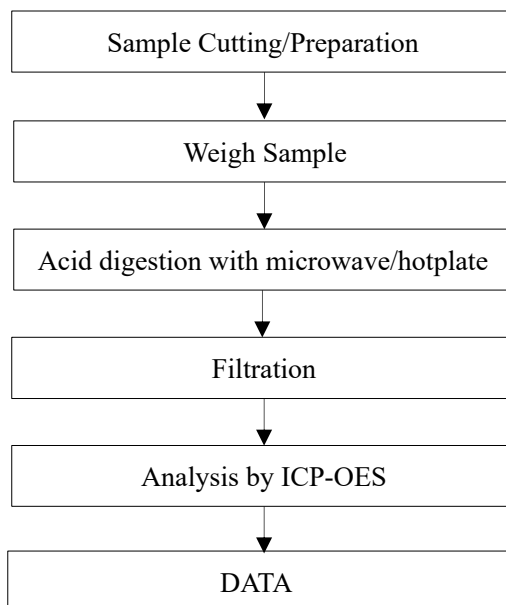

## Test Flow Chart of Heavy Metal Content



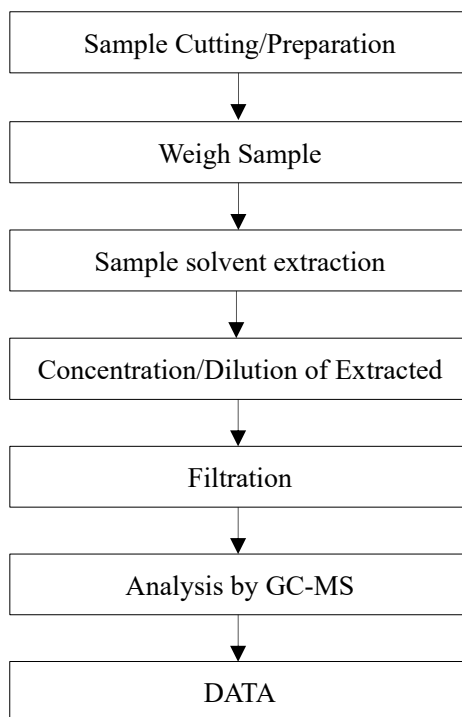

### Test Flow Chart of Phthalates



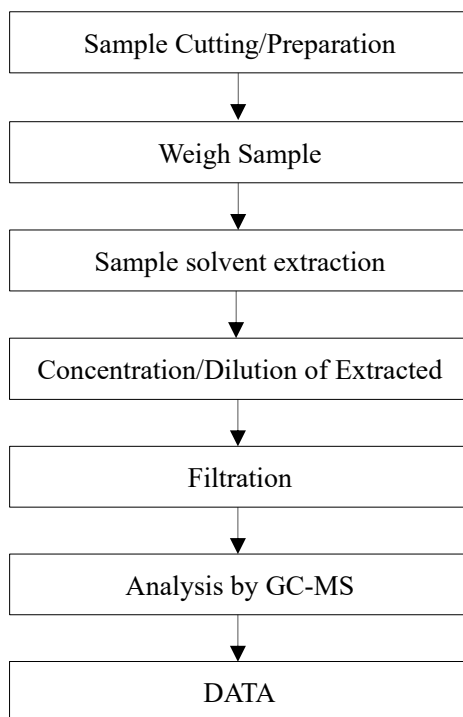
