

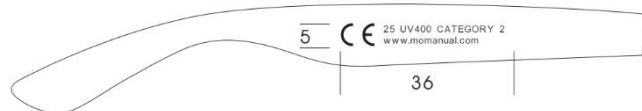

- Keep away from chemicals, and try not to let sunglasses contact perfume, cosmetics and other things containing chemical ingredients, so as to avoid damage to sunglasses, which may lead to fading or deformation of the lens frame, and lens peeling. Once stained, please clean it up in time. In addition, if you sweat a lot, you should wipe it clean in time.

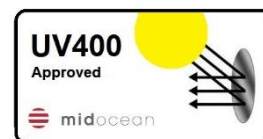
