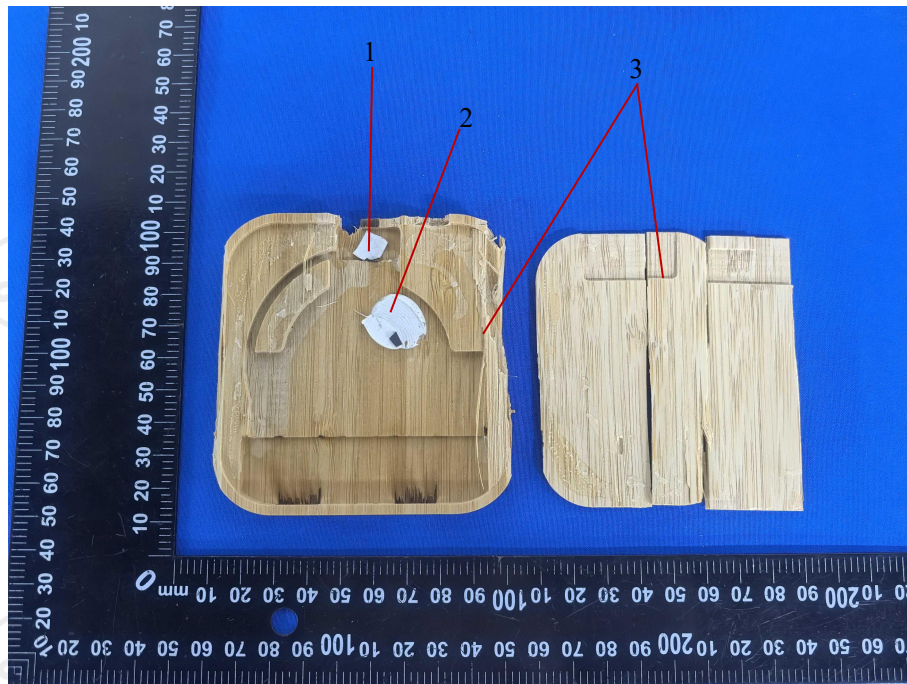

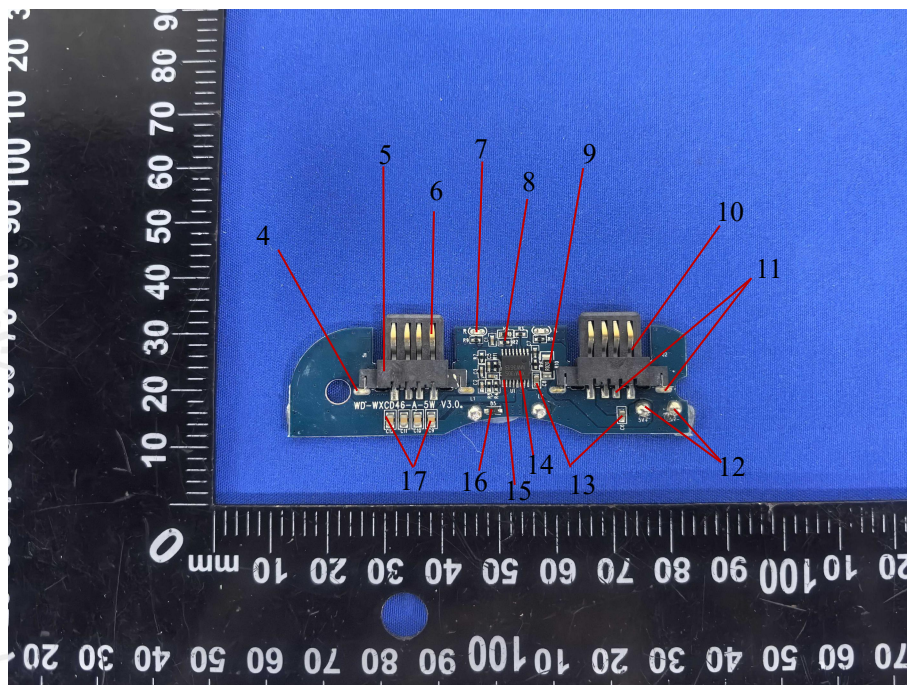

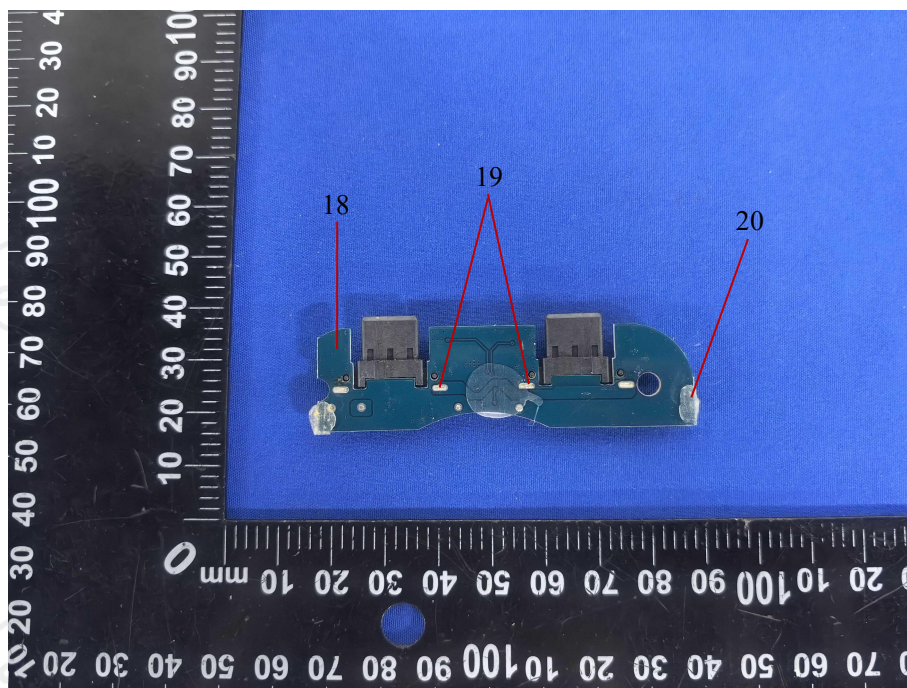

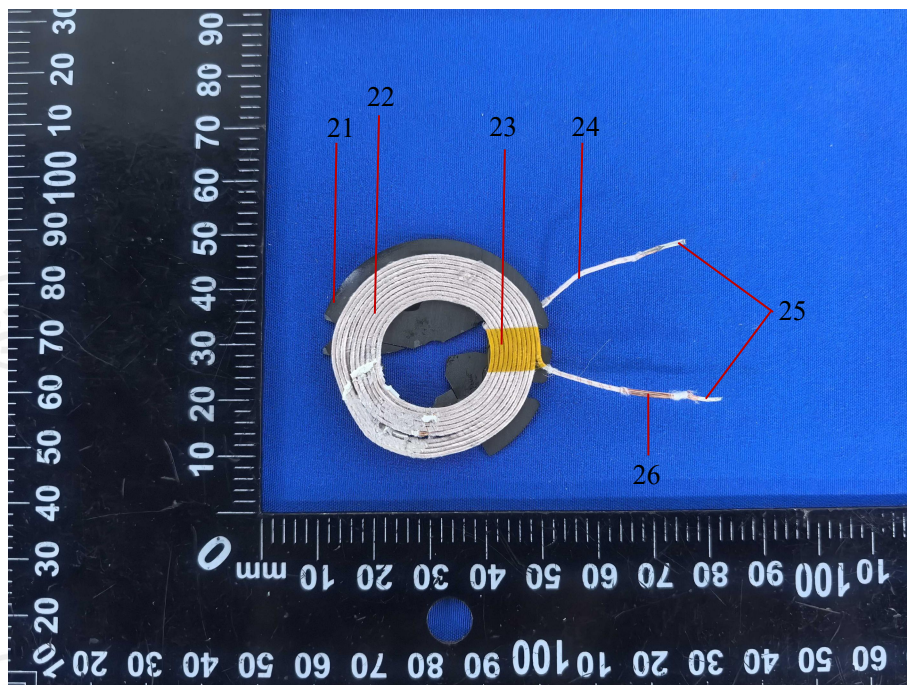

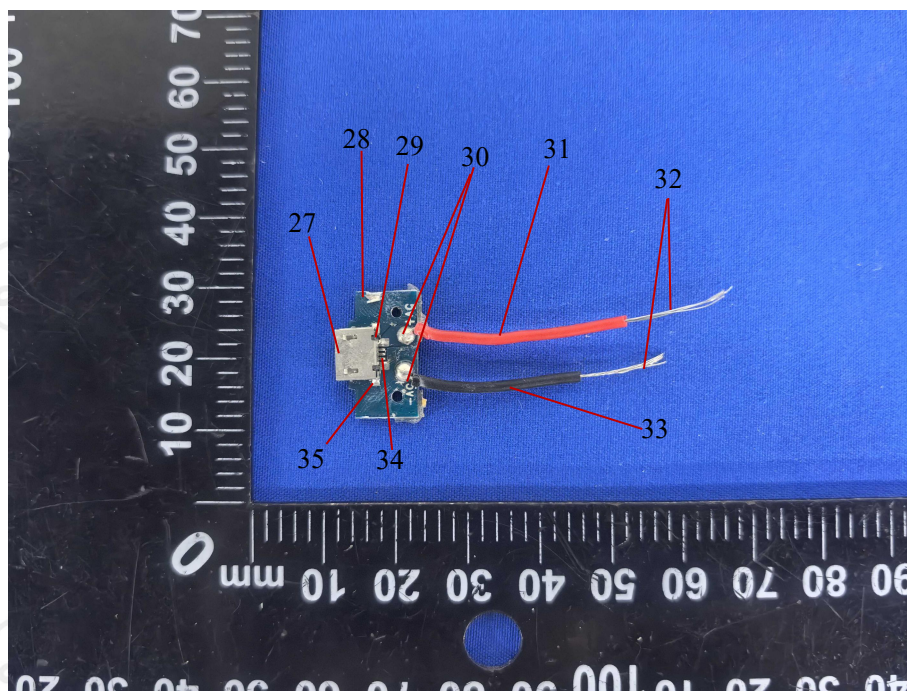

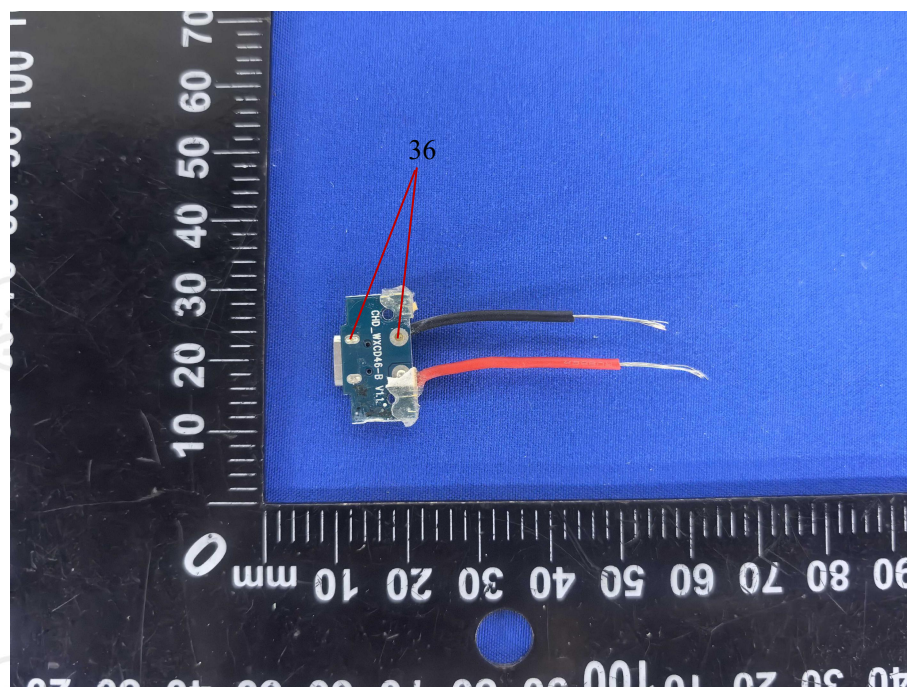

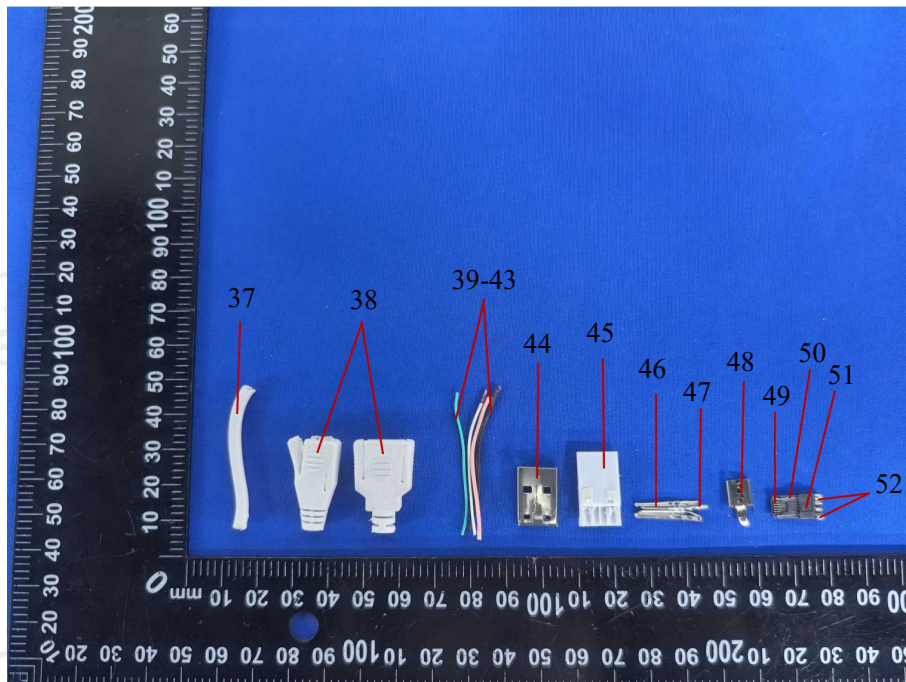


Appearance photograph of data wire

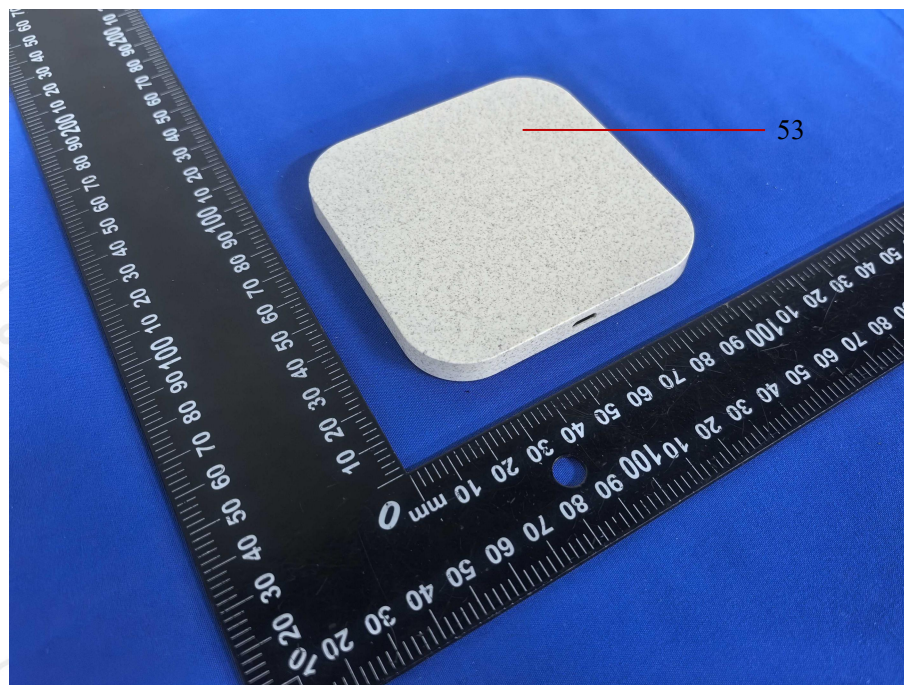

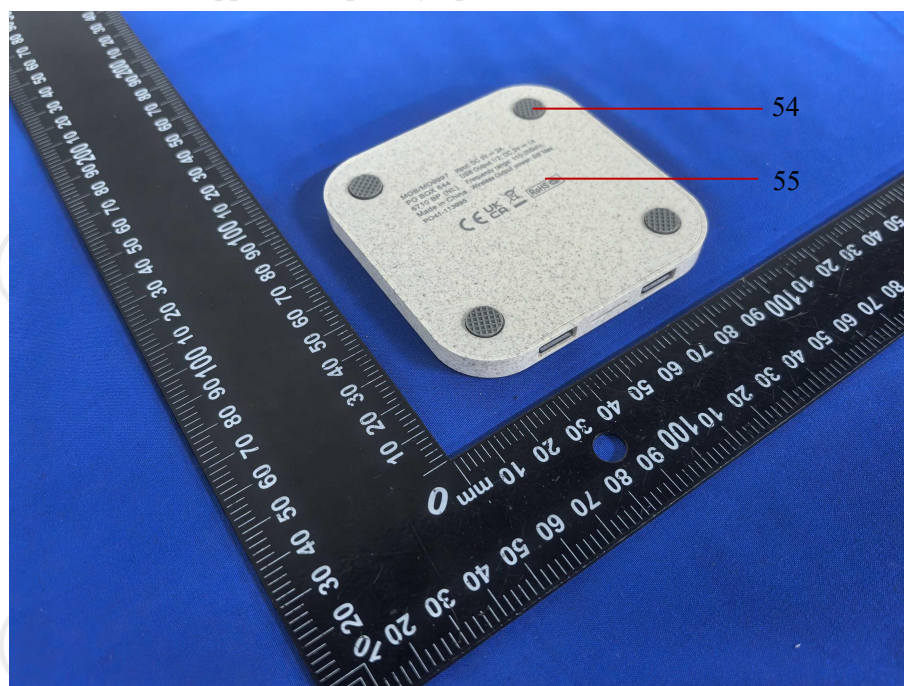

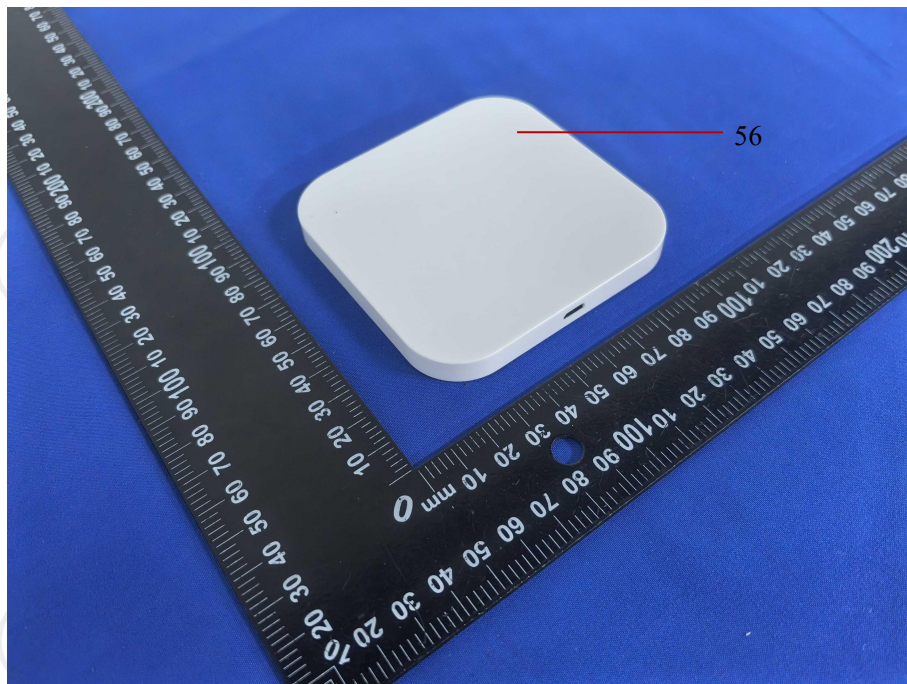

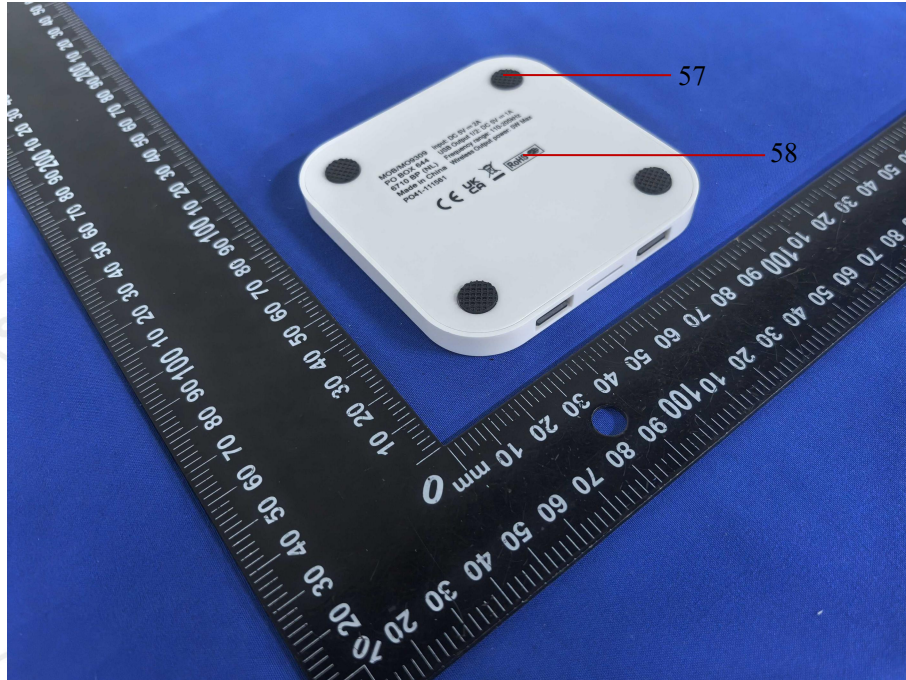

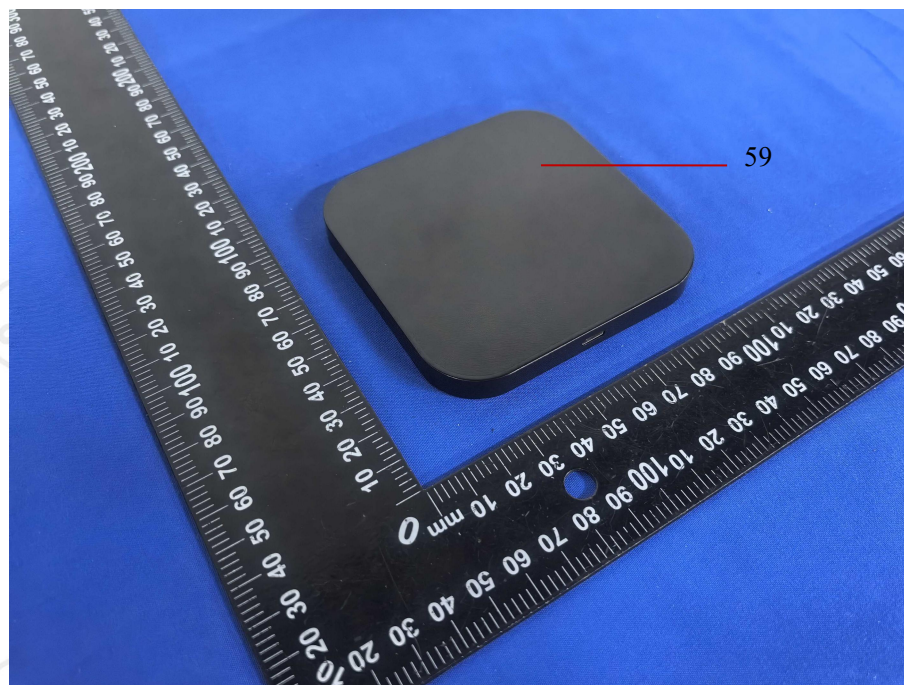

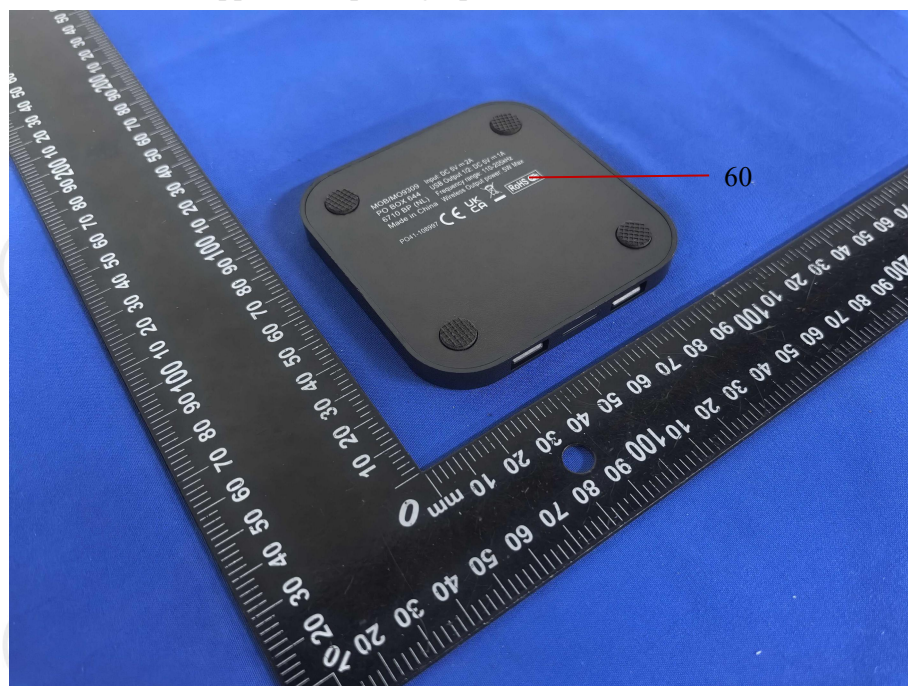
