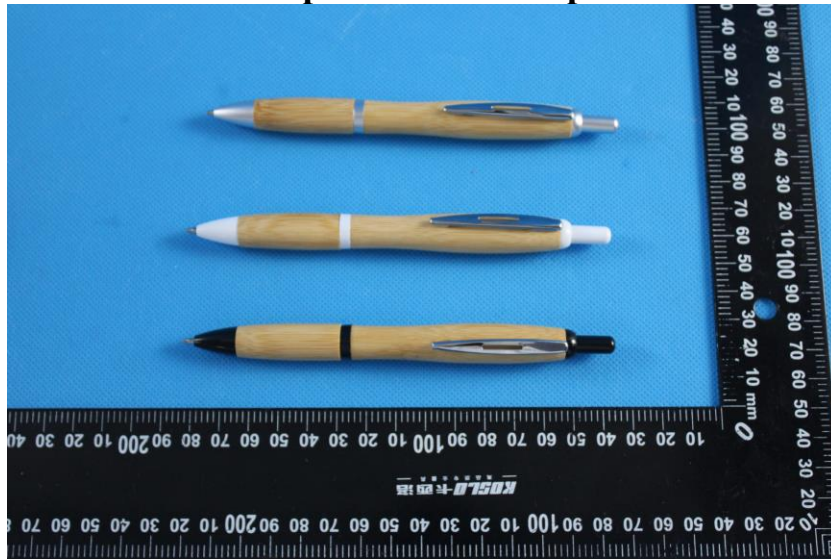

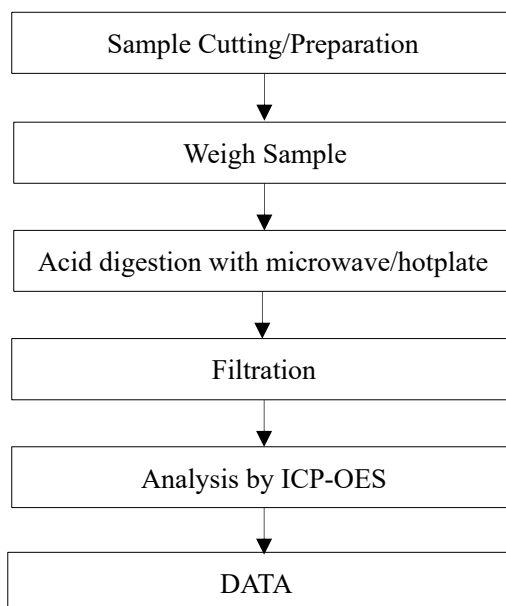

Test Flow Chart of Heavy Metal Content



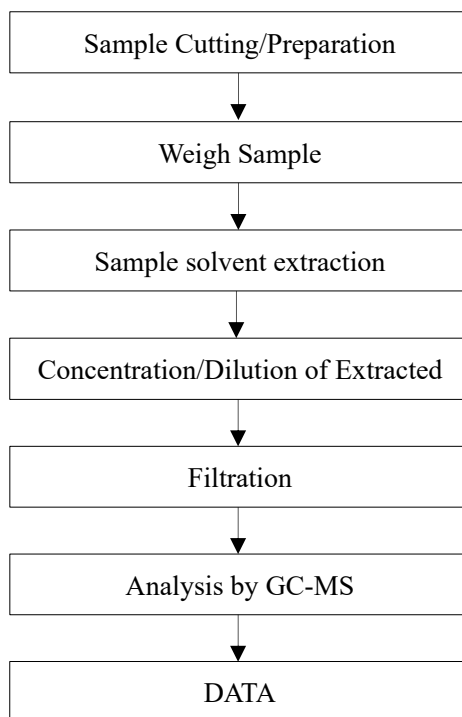

Test Flow Chart of Phthalates

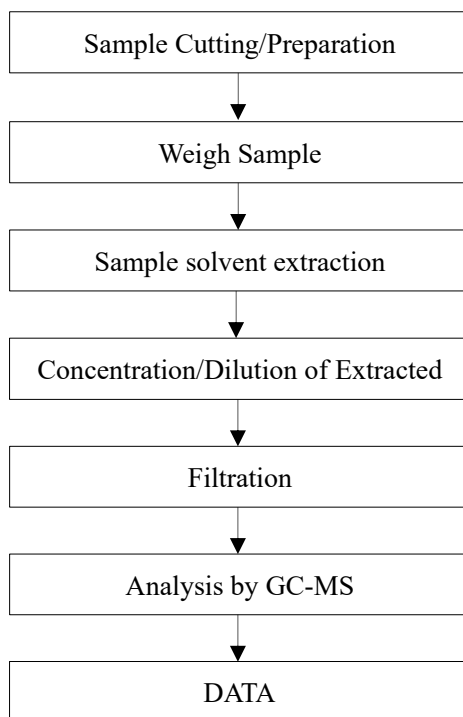

Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)

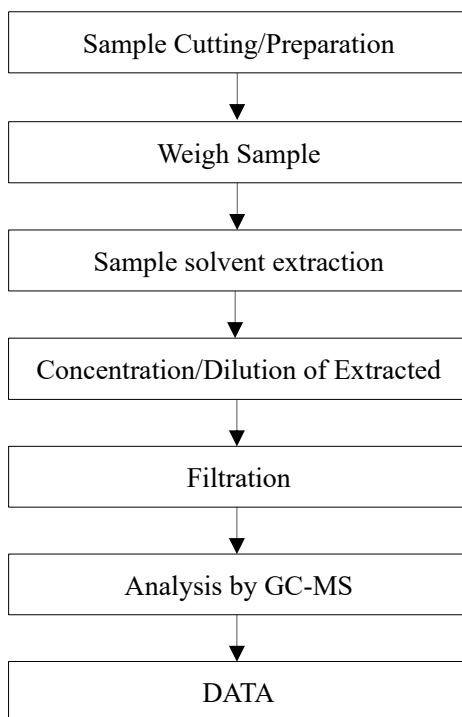

Test Flow Chart of Pentachlorophenol (PCP)



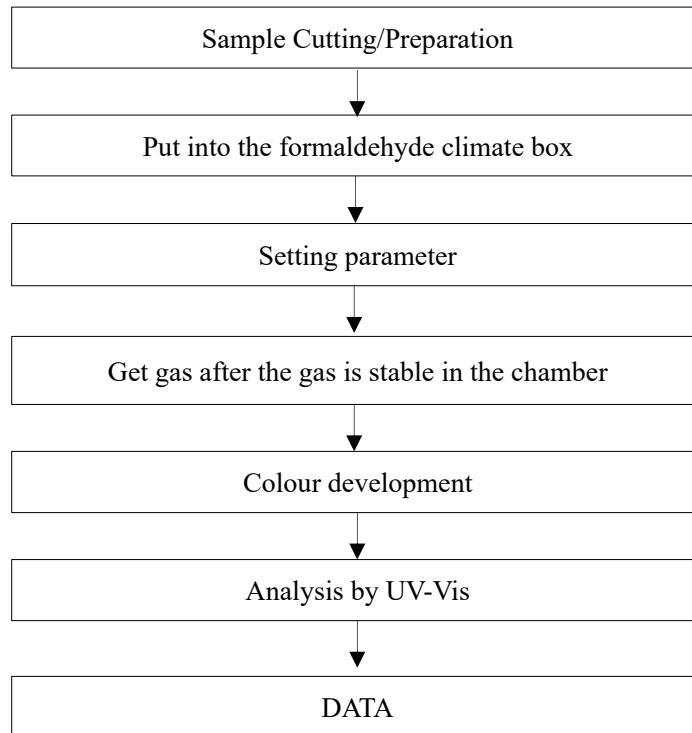
