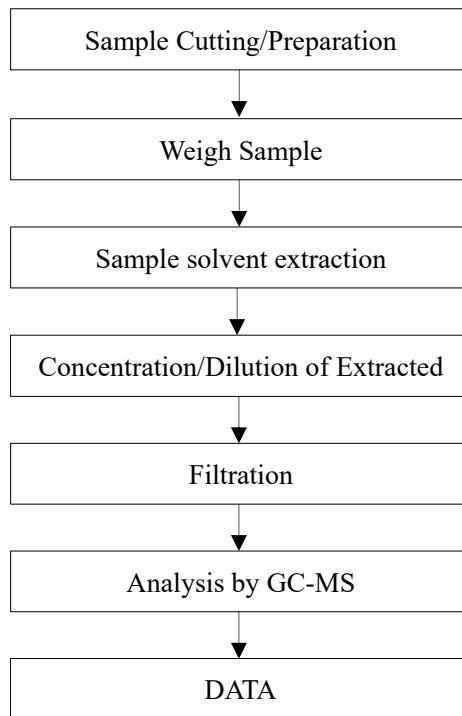

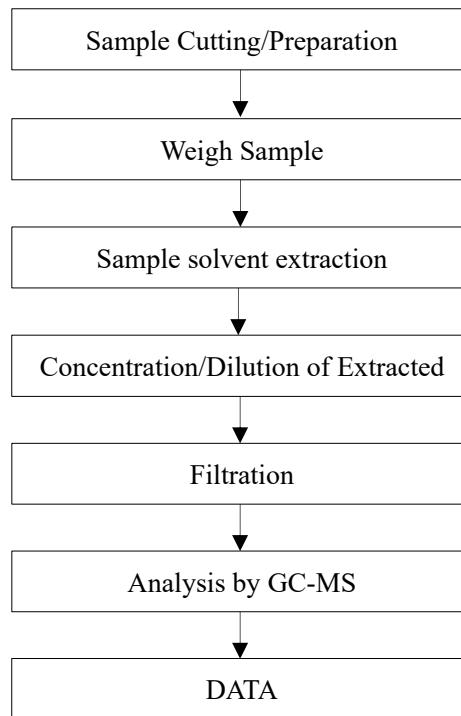

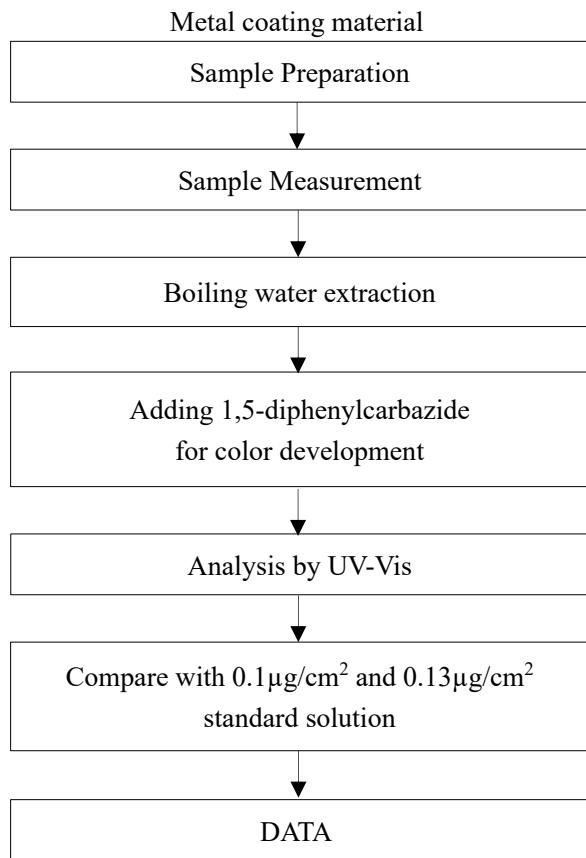
**Test Flow Chart of PBBs and PBDEs**
